

- 4. The transferred officers should prepare a list of all important and time bound matters under their charge and hand over the same to the incoming officer taking over the charge with copy to the controlling officer, under Certificate of Transfer of Charge, as mandated by GFR 33, Rule 78. The officers handing over the charge shall also prepare a note for the successor in terms of DoP&T OM. No.13024/01/2014-TRG (Trg-Ref) dated 26.09.2014. All DC/ACs will ensure that all the handing over and taking over are done properly before relieving of the concerned officers.
- 5. All the representations of the officers for transfer/retention received till date hereby stands disposed of.
- 6. No representation whatsoever shall be entertained before the officers join at their new place of posting.
- 7. All the officers under order of transfer must be relieved on or before 06.09.2024.
- 8. The officers from Nagpur-II Commissionerate are directed to submit their joining reports along with their relieving orders to ET-1 Section HQrs. The officers joining from other Commissionerates are directed to report at ET-1 Section and complete their joining formalities.
- 9. The creation of SSOID, Gov mail id and mapping in e-office of the officers who have joined from the other Commissionerates should be completed on priority basis. The DC/ACs incharge of these officers should submit a compliance report to ET-1 Section HQrs within 15 days of their joining.
- 10. This issues with the approval of the Commissioner, CGST & Central Excise, Nagpur-II Commissionerate, Nagpur.
